ORDER

This petition is filed under Order XXXIX Rule 1 of CPC by the plaintiff in OS No.14 of 2026 seeking a temporary prohibitory injunction

against the defendant/respondent.

2. Heard the counsel for the petitioner.

3. The affidavit filed by the petitioner and the documents produced by the petitioner show that the petitioner has a prima facie case. If notice is issued, delay will defeat the purpose of granting an injunction. Hence, prior notice to the respondent is dispensed with, and a temporary injunction is granted restraining the respondent, its directors, promoters, employees, agents, or any person acting on its behalf, from organizing, conducting, or marketing any programme under the trade name "Indian Space Olympiad (ISO)" or any mark which is deceptively similar to the plaintiff's marks "Indian Space Science Olympiad (ISSO)" and "International Space Olympiad (ISO)" until 04.08.2026. The petitioner is directed to comply with Order 39, Rule 3(a).

4. Issue notice to the respondents.

5. Await return of notice to 04.08.2026.
